

Intending Tenders will have to produce valid up to date attested copy of Income Tax return, PAN Card, GST registration Certificate (if any), Profession Tax Certificate, Credential Certificate etc. along with the application those will not be returned.

1. I.T, GST & Construction Cess will be deducted as per Government Rule.
2. The bidders must deposit the earnest money in the Form of Bank Draft in favour of the undersigned.
3. The rate quoted should be inclusive of all taxes, loading, unloading, royalty, stacking etc.
4. Tenders must be sealed and the Tenderers must fulfill the norms and conditions. The name of the work must be superscribed on the body of the Tender Cover.
5. The intending Tenderers must satisfy themselves about the site condition so that no extra conveyance will rise in future
6. The undersigned reserves the right to reject any or all tenders without assigning any reason what so ever.
7. Work Order will be issued after placement of fund
8. The earnest money deposited will be released to the unsuccessful Tenderers after 10 (ten) days from the date of tender.
9. 10% security of the amount including earnest money will be deducted from the R.A./ Final bills which will be released after 6 months from the date of completion of the supply /works
