



TERMS AND CONDITION

1. Intending Tenders will have to produce valid up to date self attested copy of Trade License, Income Tax return, PAN Card, GST registration .GST Registration Certificate, Profession Tax Certificate, Credential Certificate, Balance Sheet, Profit & Loss etc. along with the application those will not be returned.
2. I.T, GST & Construction Cess will be deducted as per Government Rule.
3. The bidders must deposit the earnest money in the Form of Bank Draft in favour of the undersigned.
4. The rate quoted should be inclusive of all taxes, loading, unloading, royalty, stacking etc.
5. Tenders must be sealed and the Tenderers must fulfill the norms and conditions. The name of the work must be superscribed on the body of the Tender Cover.
6. The intending Tenderers must satisfy themselves about the site condition so that no extra conveyance will rise in future
7. The undersigned reserves the right to reject any or all tenders without assigning any reason what so ever.
8. Work Order will be issued after placement of fund.
9. The earnest money deposited will be released to the unsuccessful Tenderers after 10 (ten) days from the date of tender.
10. **3% security** of the amount including earnest money will be deducted from the R.A./ Final bills which will be released after **6 months** from the date of completion of the supply /works
11. Rate should be quoted both in figer and words in the Tender. To avoid confusion, over writing of rates will not be considered.
12. Any inferior of materials is reported to have been supplied at the site or any irregularity is found during execution of the work the mated contractor as per law and the earnest money so deposited will be forfeited to Govt.
13. The work should be done as per plan and estimate of the scheme and no duration will normally be allowed unless it is approved by the authority concerned.
14. Payment will be entertained after taking measerment of the work at the site by the concern J.E. subject to availability of fund.
15. In the event of tender being submitted by a farm, it must be signed by each member there of or in the event of absence of any partner, it must be signed in his belief by aperson holding power of attorney authorizing him to do so.
16. Any incomplete of fictitious tender detected after words will be rejected without assigning any reason.
